1. These terms and conditions are not all inclusive. Announcements made from the auction podium take precedence over any previously printed or any other oral statements made.
2. There is a Buyer's Premium on all merchandise.
3. A \$25.00 title fee will be charged for each title. Titles will be mailed 10 business days after the auction.
4. All items are sold "As Is, Where Is," without any warranties or guarantees, either expressed or implied. The undersigned Bidder agrees to accept the items purchased through sealed bid "As is, Where Is, with All Faults."
5. All Sales are Final. The Bidder further acknowledges that he has purchased these items, at his discretion, and has not physically inspected the items.
6. Payment is due according to the terms & conditions of the applicable sale. Payment shall be made in the form of cash; company or personal checks will be accepted when accompanied by a letter of guarantee from the bank. MasterCard & Visa and wire transfer accepted.
7. Collusive or pooling of bids will not be tolerated.
8. NO TRADING OF AUCTION ITEMS. This means buyers cannot sell any item or part of any lot to anyone else while either party is on the auction premises. No items will be switched between buyers even when both buyers are present. Violators face permanent expulsion from the auction premises and all future sales.
9. Sales tax will be collected unless an appropriately executed Sales Tax Exemption form is submitted at the time of registration. (Sales tax may be refunded upon prompt completion of tax exemption form.)
